Definitions used herein include:

"Breeder", "We", "Us" shall be defined as **RustyAmber Labradoodles**

"Buyer", "You", "Your" shall be defined as

"Puppy", "Pet Puppy" shall be defined as

A pet puppy recorded with the Australian Labradoodle Association with the registered name of **xxxx** with Microchip #**xxxxxx**

You understand that the sale of this puppy is as a pet only and not a breeding prospect.

The puppy described above is sold for the total sum of **\$4400 including GST**. Payment are to be made in full before Puppy is released by the breeder.

1. Health /Genetic Guarantee

We guarantee that your puppy is in good health, as far as appears to the eye, and that it has received appropriate medical inoculations, worming and care. We will supply a list detailing medical treatment your puppy has received and any future care we feel is essential to your puppy's well-being. We do not assume any liability for any injury to the puppy after you have taken delivery. We will not be held responsible for the development of any disqualifying faults, diseases or disorders, which are due to your negligence and/or environmental factors.

Should your Puppy, before the age of two years, be diagnosed with any genetically derived medical disorder that makes your puppy unsuitable as a pet we will provide you with the following options.

(NOTE: The condition must be confirmed by two un-associated veterinarians (one to be chosen by you and one (chosen by us). You agree to authorise your chosen veterinarian to release to us and our chosen veterinarian copies of all medical reports relating to the puppy held by your veterinarian. You agree that all veterinary cost and testing expenses associated with the puppy are your responsibility.)

- A. If your puppy is found to have a serious genetic condition that will seriously affect its quality and/or length of life:
- You, in agreement with us, can choose to select another similar puppy from an upcoming litter, or
 - We will provide a refund of 50% of the purchase price to you.

- B. If your puppy is found to have a genetic problem that can be corrected by veterinary treatment, we will reimburse up to a maximum of 50% the purchase price of the puppy for the balance of any costs not covered by any Pet Insurance Policy held by you. You agree to make all reasonable efforts to claim treatment costs under any Pet Insurance Policy held by the you.

You must consult with us prior to commencing any treatment. Costs of any treatments undertaken without our prior express and written approval will not be reimbursed.

Due to the increasingly commercial nature of modern veterinary practices, we require you to provide us with copies of quotes you have received for any proposed treatment. This allows us to consult with our own veterinarians and consider if:

- i) the proposed treatment is necessary and like to be effective in treating the diagnosed condition; and
- ii) the proposed costs are reasonable.

Only once we provide written authorisation for the treatment recommended will you have approval for treatment to proceed under this clause. Re-imburement will only be made on presentation of veterinary receipts for approved treatments.

2. Shedding Guarantee

You understand that the Australian Labradoodle is an emerging breed. This means that it is impossible to give a 100% guarantee that your puppy will not have a shedding coat. To the best of our ability this puppy has been selected as a non-shedding puppy. Normal grooming will always result in removal of hair from the coat and is not considered shedding.

If your puppy begins shedding significant amounts of hair you may seek one of the following compensations.

- i) If the puppy is returned to us by 12 weeks old, you may have a full refund or a replacement puppy from an upcoming litter.
- ii) If you decide to return the pup to us from 6 to 12 months of age, we will refund you 50% of the purchase price.
- iii) You may choose to keep the puppy and receive a refund of \$1000 to take the pup back to the normal shedding purchase price. We reserve the right to inspect the puppy to confirm shedding before any refund is made. No refunds under this option will be made until the puppy reaches 12 months of age.

3. General

You understand that the Australian Labradoodle is an intelligent dog that is slow to mature by nature. Your puppy will require early socialization and training. We strongly recommend that you attend obedience classes with the puppy and provide proper socialization opportunities.

You know how much we care about our dogs going to a good home, so you agree to never relinquish the puppy to an animal shelter or rescue organization. We will assist you (if required) in finding a suitable new home for your dog if the need arises during its lifetime.

There are many factors that can influence the growth, development and health of a puppy, such as diet, exercise, weight, environmental conditions etc. In accepting delivery of this puppy you assume the responsibility to continue with the appropriate vaccinations, worming, and health care as outlined in the schedule supplied by us. You agree to feed the puppy a high-quality diet and maintain your puppy at a healthy weight throughout its growth period and to prevent excessive exercise or activities that will put strain on growing limbs.

Should you not fully comply with all of the above provisions of this agreement, the remainder of this agreement will be considered null and void.
